LEATHERGRAIN PLASTISOL GUARANTEE FOR UP TO 30 YEARS

The manufacturer guarantees that, once buildings are registered with us, the external P.V.C. coating on the galvanised substrate (“the Product”) will, over a period shown on page 4 attached from delivery of materials to first repainting, show no more than 5% flaking on any single slope or wall, subject to the conditions listed in this P.V.C. Guarantee.

OBLIGATIONS OF PROPRIETOR

The proprietor of the building must satisfy the terms and conditions of the guarantee, including at least an annual inspection and washing of all slopes and walls.

We must be informed within one calendar month, of any claims of suspected failure and prior to 10% of any single slope or wall becoming affected. Then be given the chance to inspect the affected area, and take appropriate action they deem necessary to be restored to meet the remainder of the guarantee.

TERMS AND CONDITIONS

- The manufacturer (we) guarantees that buildings, clad in their P.V.C coated materials, will show no more than 5% flaking of top coat on any surface, within twenty years from delivery of materials.
- The guarantee must be registered with us, within six months of the building being handed over to the proprietor, by completion of the application form attached. Time being of the essence.
- Claims must be made in writing within one calendar month of suspected failure and prior to 10% of any slope or wall becoming affected.
- We must be given the chance to inspect the affected area.
- We agree in relation to valid claims to take appropriate remediable action they deem necessary to restore any areas that are in breach of this guarantee
- The terms and conditions of this guarantee apply to the restored area for the remainder of the term of the guarantee.
- The restored affected area may show a slight colour variation due to the weathering process of the original panels
- In relation to the above terms and conditions time shall be of the essence unless stated otherwise.
- The guarantee is only available to the party named on the guarantee certificate and it is not intended that any provisions of this guarantee are to be enforceable pursuant to the Contract (Rights of Third Parties) Act 1999 by any person who is not a party thereto.

LIMITATIONS AND EXCLUSIONS

The guarantee only applies to the external P.V.C. top coat only provided that it has not been overpainted or touch up paint used or any other work has been carried out to the surface without our consent. The backing (internal) coat is not covered in this guarantee.

Our liability shall be limited to the cost of labour, equipment and material only of restoring any affected area and shall not include any direct, indirect or consequential losses.

We shall not have any liability under this guarantee or otherwise in relation to the defective installation of the Product or any damage caused to the Product during the storage, handling or erection of the Product by any installer.

This guarantee supersedes any other warranties or guarantees, in respect to the Product, whether express or implied.

Guarantee does not apply to damage caused to the Product by; fire, explosion, chemicals, impact, lightning and other extreme or abnormal weathers, and other causes beyond the reasonable control of ourselves including but not limited to wilful acts, misuse and negligence whether by the installer of the Product, the proprietor of the Building or any third party.

In addition to the above exclusions, where the guarantee becomes invalid include the following:-

- Lack of or insufficient maintenance and washing of Product.
- Defective draining of water on slope and sealing of overlaps.
- Exposure to harmful and corrosive; metals, materials, substances, chemicals, fumes and gases and temperatures greater than 60° C however caused.
- Storage, handling, maintenance and erection of the Product including fixings and sealant as a result of not following recognised industry standards.
- Roof pitch and that of any slope which is below 4°.
- Any repairs or other works carried out on the Product without our written consent.
